Qualification and Disqualification as per Bye-laws are reproduced below:

i. **QUALIFICATION OF MEMBERS OF EXECUTIVE COMMITTEE:**

a. The Life Members and Ordinary Members of the Bangalore Sports Centre, whose names are appearing in the register of members of the Bangalore Sports Centre and who do not suffer from any legal disabilities and subject to the other conditions and restrictions contained hereunder shall be eligible to be elected as Executive Committee member of the Bangalore Sports Centre.

Explanation: For the purposes of this clause "Ordinary member" shall also include "Special Member (other than nominees of Institutional Member / Institutional Associates)" of the Bangalore Sports Centre;

Note: - The cut-off date for being on the rolls / records of the association shall be reckoned as on at least one month prior to the date of the notice to be issued by the Assistant Secretary of the Bangalore Sports Centre for the Annual meeting.

- b. Each of the elected member of the Executive Committee shall have a term of 3 years in office, subject to a maximum of nine years on the Executive Committee.
- c. Any person to be nominated by the KSCA Managing Committee shall be a member of the Bangalore Sports Centre hailing from Karnataka and shall not suffer from any legal disabilities and shall be subject to disqualifications stated hereunder.

ii. <u>DISQUALIFICATIONS FOR MEMBERS OF THE EXECUTIVE</u> <u>COMMITTEE:</u>

A person shall be disqualified from being a member of the Executive Committee, either elected or nominated if he or she:

- (a) is not a citizen of India;
- (b) has attained the age of 70 years;
- (c) is declared to be insolvent, or of unsound mind;
- (d) is a Minister or a Government Servant or holds public office;
- (e) has been an Executive committee Member, either as an elected member or as a nominated member of KSCA Club House / Bangalore sports centre for a cumulative period of "9 years".
- (f) has been charged by a Court of Law for having committed any criminal offence, i.e. an order framing charges has been passed by a court of law having competent jurisdiction; or
- (g) If he / she has been an office bearer or a member of the managing committee (elected / nominated / representative of the Founder Institutional member) of KSCA for a cumulative period of 9 years.
